## **Declaration**

- 1. **Accuracy:** The details set out in the Application for Membership Form are true and correct. If they change, I acknowledge that I am required to notify my Club of the changes, in writing, as soon as possible after they occur.
- 2. **Bound by Rules:** I will be bound by the constitutions, regulations, policies, manuals, guidelines, and reasonable directions of Cambridge Racquets Club (CRC), and the Regional/National Sports Organisations (RSO/NSO) which CRC is a member.
- 3. Accept Risk of Tennis: I have voluntarily accepted and assumed the inherent risk of danger and injury in tennis and/or squash.
- 4. **No liability:** I will not hold CRC, the RSO/NSOs of which CRC is a member or their respective officers responsible for any claims, losses, expenses and costs (including legal costs) which may arise from or in connection with my membership and/or participation in any activity authorised or recognised by CRC or the RSO/NSOs of which CRC is a member, except in the case of gross negligence or a willful act or omission on the part of CRC or the RSO/NSOs of which CRC is a member.
- 5. **Indemnity:** I indemnify CRC or the RSO/NSOs of which CRC is a member from all claims, losses, and expenses (including legal costs) suffered or incurred at any time as a result of, or resulting directly or indirectly from, my failure to observe the constitutions, regulations, policies, manuals, guidelines, and reasonable directions of CRC or the RSO/NSOs of which CRC is a member.
- 6. **Medical Declaration:** I am medically and physically fit and do not suffer from any injury, disease, or condition, either physical or mental, that would affect my ability to safely participate in any authorised or recognised activities of CRC or the RSO/NSOs of which CRC is a member. If I am unsure about this declaration or suffer from such a condition, I have either listed it on the application for membership form or I am aware that I must bring it to the attention of my CRC.
- 7. **Privacy:** I agree that CRC or the RSO/NSOs of which CRC is a member can collect, hold, use and disclose my personal information on the Application for Membership Form (and any updated or additional personal information my CRC or the RSO/NSOs of which CRC is a member obtains from me whilst a member including any photo or other record of my image) for the purposes of:
  - a.) Processing my application for membership including notifying the RSO/NSOs of which CRC is a member of the information on the Application for Membership Form for the purposes of my CRC compiling a register of members in accordance with the Incorporated Societies Act 1908 and for the purpose of the RSO and NSO compiling a national database of members and participants (accessible only by CRC or the RSO/NSOs of which CRC is a member);
  - b.) Publishing my name and contact information on CRC's membership list for use by other members of my club.
  - c.) Publishing any of my tennis results in CRC or the RSO/NSOs of which CRC is a member newsletter and on their websites.
  - d.) Selecting and naming publicly players, officials, and teams to represent CRC or the RSO/NSOs of which CRC is a member at tennis and/or squash events.
  - e.) Providing me with information and activities relating to CRC or the RSO/NSOs of which CRC is a member and other tennis/squash matters.
  - f.) Enabling sponsors and funders of CRC or the RSO/NSOs of which CRC is a member to contact me with information about their product and services.
  - g.) Publishing of photos within club publications, CRC website and official club social media channels.
  - h.) Enabling CRC or the RSO/NSOs of which CRC is a member to comply with any statute, regulation, by-law, or other regulatory instrument that requires collection or disclosure of my personal information; and
  - i.) Any other purpose I agree to in writing.
- 8. **Use, Security and Access:** I understand that my personal information will only be used for the purposes listed in paragraph 7 and that:
  - a.) My personal information will be held securely.
  - b.) I will have access to my personal information.
  - c.) My personal information will be corrected upon request.
- 9. **Continued Membership:** I understand that upon payment of my membership fee/s, I will become a member of CRC and that by paying such fee/s by the due date/s, I will continue to be a member of CRC, unless I resign, or my membership is terminated.
